CAMP AMERICAN LEGION----FALL CLOSING 2013

The annual Fall "work week" for closing Camp American Legion for Ozaukee County was the week of Sept 30th. A total of 98+ Legionaries, SAL's, Auxiliary Members, and Volunteers from around the State showed up at various times to close Camp. Ozaukee County had (39) Legionnaires, SAL's, and Volunteers in Camp for Fall Closing:

All Piers removed by a Group from Grafton. All Boats and Pontoons boats removed and stored as required.

Butch and Leroy of our Post completed the repairs in the Restroom of the Maintenance Shed---this is a project they started last spring. A window had been leaking and some of the plywood paneling on the wall was rotting. All is complete with a nice fresh coat of white paint.

Our SAL Squadron, new sponsors of the King Cabin, began cleaning up the lot.

Major Capital improvements completed this year: New Lake access and boat landing by Nat Guard, new Cabin 14, completion of the Split Rail fence, New Chapel and a new Waterfall.

Total attendance at Camp this year was fantastic! 544 veterans---then adding in the Care Givers, family members, and the Staff members of the special groups and we end up with a total of 1026 this year compared to 894 last year. That is a 100% increase from 2010 when there was 508.

Spring Opening has been set for April 21st thru May 3rd.

From our Ozaukee County Service Officer

Fully Developed Claims (FDCs) are claims for service-connected disability compensation that are submitted to the VA with all supporting evidence necessary to decide the claim.

The FDC program was initiated by the VA as an attempt to reduce the inventory of pending claims. When all of the supporting evidence is NOT submitted with a claim for disability compensation, the VA is legally required to attempt to obtain this information on the veteran's behalf.

However, often times this information (such as private medical records or employment records) is much more easily obtained by the veteran. Routinely, it is the VA's development efforts that slow the claims process. By submitting a claim together with all of the supporting evidence necessary to the decide the claim, the

veteran can assist the VA in significantly reducing the processing time.

Under a new law in effect from August 6, 2013 through August 5, 2015, veterans who submit an FDC for their very first claim for service-connected disability compensation may be eligible for an additional year of retroactive disability benefits.

VA continues to implement other initiatives as well, including priortitizing claims more than one year old and mandating overtime for claims processors in the 56 regional benefits offices nationwide.

As a result of these initiatives, VA reports that the inventory of pending claims is lower now than it was in August 2011 with the number of claims that have been pending longer than 125 days reduced by 17% compared to the peak in March 2013.

Are You Dedicated and Reliable?

Then I WANT YOU to drive. Ozaukee County provides an extremely valuable service by transporting veterans to the VAMC or CBOC for medical appointments.

The County reimburses our drivers for mileage and pays a small per-veteran stipend. However, I know that none of our drivers do it for the money.

Ask any of these guys why they do it and you will learn that they know what it means to be able to rely on

someone else, to know that someone else is there for you and has your back -no matter what.

Do any of you remember learning this proclamation in school?

In November 1919, President Wilson proclaimed November 11 as the first commemoration of Armistice Day with the following words: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice in the councils of the nations..."

Whereas the 11th of November 1918, marked the cessation of the most destructive, sanguinary, and far reaching war in human annals and the resumption by the people of the United States of peaceful relations with other nations, which we hope may never again be severed, and

Whereas it is fitting that the recurring anniversary of this date should be commemorated with thanksgiving and prayer and exercises designed to perpetuate peace through good will and mutual understanding between nations; and

Whereas the legislatures of twenty-seven of our States have already declared November 11 to be a legal holiday: Therefore be it Resolved by the Senate (the House of Representatives concurring), that the President of the United States is requested to issue a proclamation calling upon the officials to display the flag of the United States on all Government buildings on November 11 and inviting the people of the United States to observe the day in schools and churches, or other suitable places, with appropriate ceremonies of friendly relations with all other peoples.

Remember please that WE would not be able to enjoy all of the fun things I mentioned above without our Veterans! Join your Auxiliary and Thank every Veteran you see every day for Their Service/Sacrifices and your FREEDOM.

These men and women are in treatment for substance/alcohol abuse, trauma caused by assault, PTSD, etc. The maximum stay is 90 days. Most have nowhere to go once released. For the past 2 years, through the generous support of Auxiliary Units, two Sons of the American Legion Squadrons, and many individuals, 2nd district has been able to provide a Christmas bag consisting of basics: a pair of gloves, socks, a knit hat, and a \$5.00 gift card to Pick N Save, plus some miscellaneous items. This year our goal is 240 bags. We'd appreciate any donations. Your items (or monetary donation and we'll do the shopping) can be dropped off during our next Unit meeting on Tuesday Nov 19th. Our contact information is listed below for any questions/to arrange pick-up. Deadline is December 1st. We've been told that for many of these Vets, this is the only gift they will receive this Holiday Season. Thanks for your generosity in making Christmas a little brighter, and winter a little more bearable, for these Vets who have given so much to preserve our freedoms and who now find themselves in need of a helping hand.
