DEMENTIA.

Camp American Legion News

The following is a description of the current issues discovered while doing the interior demolition of the director's quarters.

While doing the originally approved demolition at the director's quarters several issues were discovered. We found significant structural issues due to poor construction, moldy and rotten wood on the exterior walls and roof joists, and mouse infestation causing an unhealthy living conditions. There is insufficient and non-compliant building code issue in the following areas: Roof structure support, load-bearing headers and walls, electrical, plumbing, and building insulation heat loss factors. We had four contractors look at the structure and evaluate the structure for safety and code compliance issues. All of the contractors suggested that we demolish the structure down to the main floor deck, level the main deck as best as possible, and rebuild the structure using 2x6 construction and clear span trusses. One builder, (Wausau Homes) suggested we demolish the entire structure, poor a new foundation and rebuild the entire house. However, the costs of doing this would be nearly \$75,000 more than the cost to rebuild from the main level deck up.

Some of the materials have been removed to be re-purposed. All but one of the kitchen cabinets will be used in the craft shop. One cabinet had significant black mold form water leaking thru the roof. The water heater will be re-installed in the house. The steel roofing will be removed and saved for the cabin 22 rebuilding project. The boiler will be saved and sold or re-used in cabin 21 when it is rebuilt. All the copper piping will be scraped for salvage pricing.

We have looked at options for rebuilding completely vs. remodeling considering the budgetary impacts and the building life cycle longevity. These issues have set us back 2 weeks so far. I feel the attached proposed estimate is very reasonable. Again, we have myself and our staff that will be doing labor on this project to offset the labor costs.

State Commander Clewell has called an electronic meeting of the Department Executive Committee regarding immediate needs at Camp American Legion. I have attached the minutes of this meeting for your review. The items that they were asked to consider were:

- 1. Approval to reallocate \$14,200 from the woman's quarters renovation project to the Director's quarters. We have donor who has pledged to fund the woman's quarter's renovation project.
- 2. Approval to reallocate \$6,500 from the generator/building siding project to the Camp Director quarters. This project is mainly cosmetic not urgent.
- 3. Approval to over-spend the \$75,000 Camp Director quarters budget. (Budget Overage is \$22, 350) In terms of the budget overage of \$22,350 please be advised Camp American Legion received an estate on 11/07/2017 in the amount of \$21,613 to help offset the overage. This estate of \$21,613 has been earmarked for Camp American Legion.

We continue to receive sizable donations / estates earmarked for Camp American Legion due to the efforts of the Camp and Headquarters staff (marketing / fundraising efforts).
