### Agent Orange Exposure in the Republic of Vietnam Waters (Blue Water Navy)

Blue Water Navy Veterans are now entitled to a presumption of service connection for conditions related to Agent Orange exposure. This extension of the presumption is a result of Public Law 116-23, the Blue Water Navy Vietnam Veterans Act of 2019, signed into law on June 25, 2019. The law takes effect January 1, 2020.

The law states that Veterans aboard a vessel operating not more than 12 nautical miles seaward from the demarcation line of the waters of Vietnam and Cambodia as defined in Public Law 116-23, between January 9, 1962, and May 7, 1975, are presumed to have been exposed to herbicides such as Agent Orange and may be entitled to service connection for conditions related to that exposure. To be entitled to disability compensation benefits, these Veterans must have one or more of the conditions associated with Agent Orange exposure that are listed in 38 Code of Federal Regulations section 3.309(e).

Agent Orange presumptive conditions are:

- AL amyloidosis
- Chloracne, or other acneform disease consistent

with chloracne

- Chronic B-cell leukemias
- Diabetes mellitus, Type 2
- Ischemic heart disease
- Hodgkin lymphoma, formerly known as

Hodgkin's disease

• Non-Hodgkin lymphoma

- Multiple myeloma
- Parkinson's disease
- Peripheral neuropathy, early-onset
- Porphyria cutanea tarda
- Prostate cancer
- Respiratory cancers (lung, bronchus, larynx or trachea)
- Soft-tissue sarcoma (other than osteosar-coma, chondrosarcoma, Kaposi's sarcoma, or mesothelioma).

She also presented Chaplain Linda Brown with the National President's pin, along with the prayer cards from our Department Chaplain, Becky Mueller.

Past Unit Treasurer Pam Klenner read the Treasurer's Report. A copy of her report is on file. Pam reported that an Audit was done on August 8th by Patty Wollner and Janice Bould, and that everything went well. She noted that deposit slips are missing for two deposits made in the month of May in the amounts of \$100.00 and \$102.00. Cathy Brunnquell explained that she had made the deposits after the County meeting, and that the deposit slips were later turned-in to Pam. She further explained that \$100.00 had been withdrawn for start-up cash for the evening and then was redeposited. The deposit of \$102.00 was money received at registration that evening. Patty Wollner noted that she has not yet been reimbursed for her expenses of \$19.98 for centerpieces for that event, the receipt for which had been turned in that evening with Mel's receipts. President Sue directed that Patty be reimbursed.

Pam said she's in need of information from the Wine Tasting Committee on which businesses have our tax exempt number on file, and the names connected to them. This information needs to be made current with each business. Pam will update Amy on this procedure.

Membership Chair Lora Linder reported our 2019 membership stands at 160 members paid and 28 unpaid. The team met recently and tried to contact unpaid members. They found in many cases the information they have is outdated (emails or phone numbers have changed or no longer exist). For this reason they'll be asking members for updated information. Lora also reported that the Membership Committee's records have been turned over to Pam so that an Audit can be done. Plans are in place to have this Audit completed by the September meeting.

Linda Brown gave a report on the Trees from Home Project. This year she was able to collect almost \$700 to help with shipping costs. If anyone still wishes to donate, it must be done by the end of this week. The News Graphic did a good job for us with several pictures and an article on the recent tree decorating event. The Ozaukee Press has also contacted Linda, as they've promised to do an article as well. Linda has raised approximately \$5,000 during our Unit's five years of holding this event. Linda also announced that Judy Kuta will stand-in as Chaplain next month as Linda will be out of town.

There was no news of our members to report. President Sue reminded us that the Executive Board meeting will be on September 3<sup>rd</sup>.
