# **Highlights from our last Post meeting**

**Guest.** Ozaukee County Commander, Jim Schmidt, gave a report on:

- The 4-Chaplains Dinner will be hosted by Saukville Post. Normally is held on the first Saturday in February, but has been moved to April or May;
- Deadline for County Public Safety Awards is February 15 and March 1 for 2nd District;
- Youth and Government Day held at the old courthouse is on hold.
- All Legion members can assist to achieve goal for Posts, County, and District of 90% by January 30. "Buddy Checks" are highly encouraged.
- Jim also handed out the latest revision of the County Constitution and By-Laws.

Members present approved their replacement at a cost of \$8,235.

**Butch Paegelow** reported that the Post's annual Las Vegas Sweepstakes tickets will be mailed on January 21. He encouraged all members to participate, as this will be our only major fundraiser for the year. The winners will be drawn on April 17. Since Las Vegas Night has been cancelled, Doug Arendt suggested possible live drawing via computer technology.

**Bingo, Jim Arentz** reported that the Post's State Bingo license has been renewed. If possible, Bingo can be held next September thru February.

The picture of me was taken October, 2014 at the Marine Corps Memorial, Washington, DC. I had just completed running a 26.2-mile marathon that followed a route passing many historic sites, such as the Lincoln Memorial, Washington Monument, Arlington National Cemetery, and the U.S. Capitol. On that day thousands of spectators lined the route cheering the runners every step. It makes me very sad when I think of the riot that occurred this year on January 6 at our U.S. Capitol. Somehow changes need to be made so we can all feel safe wherever we travel. I offer the following prayer for us to reflect on.

**PRAYER FOR HEALING----**America is hurting. Covid Pandemic, racial inequalities, job loss, and political division have caused great suffering. As Christians, we can begin healing our land through prayer and action. Let us come together not just by words but a faith that produces works. The love and grace of God can begin turning the tide of America. We look to You, only, Lord. Help us make wise decisions that move our country in the right direction. Help us do our part in praying and staying with what we know is right according to the truth of Your Word. Teach us to make our actions count and our words matter. Those 4 Chaplains were; Lt. George L. Fox, Methodist; Lt. Alexander D. Goode, Jewish; Lt. John P. Washington, Roman Catholic; and Lt. Clark V. Poling, Dutch Reformed.

Our January Unit meeting was held on Monday the 18th, with 18 members present. The following Recommendations of the Exec Board meeting of December 1st were approved at this meeting:

And with Covid still in the picture, would they have had enough volunteers to run things? Following discussion of this news, a Recommendation was made that we make a donation of \$2,000 to the Legion. This was presented to, and APPROVED by the Unit at the January 18th Unit meeting. The check will be presented by President Sue Turowski to the Legion at their February meeting.

By the time you receive this newsletter, you'll already have received your Las Vegas Night Sweepstakes tickets with an explanation of the extra expenses the Legion has encountered this year. Not every Post in the County is able to own a building, much less one as nice as ours, and we need to do our part to support it. We ask that, if able, you purchase or sell all tickets sent to you (MORE TICKETS ARE AVAILABLE).

News has been received from 2nd District President Amy Luft that the Mid-Winter Conference has been rescheduled to the weekend of May 7th through the 9th. This will include an ALA In-the-Know session for which prior registration is required. The 2nd District Spring Conference (a scaled-down version) will take place at the Grafton Post on Saturday April 24th. Attendance is limited to 30 people. Watch the March newsletter for further information. The 2nd district Auxiliary sweepstakes drawing will take place that day. The tickets will be sent to the Unit soon. This is a CASH raffle and is the only fundraiser for 2nd District.

County President Cathy Brunnquell reports few County Units are meeting regularly. At this time, no Spring County meeting is scheduled. The 4-Chaplains Dinner, which usually takes place in the month of February, has been postponed until April or May.

Membership currently stands at 151 members paid, or 83% of this year's goal. Thanks to all who have renewed and to our Membership Team, Lora Linder and Carolyn Knoppa. Lora can be contacted at 262-389-5339 for questions regarding your membership status.

VA & R Chair Mel Nowak has sent a mid-year report to Department. Highlights included are that our partnership with local Girl Scouts resulted in 13 Cases of cookies being donated to the King Veterans Home, and that the value of items our Unit donated this year to Christmas with the Vets at Zablocki totaled \$2,279. This was through the participation of 28 members, who spent 174 hours on this project.

State Bowling Chair Toni Moegenburg reports reservations are coming in for the tournament. See details at the end of this newsletter.

Approved at the Unit meeting was a motion to give a \$5 gift card from local coffee shops to all members of the Fire and Police Departments as a thank-you.

This excerpt is directly from our By Laws.

### **Election of Officers**

**Section 1:** The following Officers shall be elected annually by plurality vote of the ballots cast. When there is but one candidate the nominee can be elected by voice vote or acclamation. President, First Vice President, Second Vice President, Historian, Chaplain and Treasurer

**Section 2:** The following officers shall be appointed by the Unit President subject to the approval of the Unit and shall hold office at the will of the appointive power.

Secretary, Sergeant-at-Arms, Assistant Sergeant-at-Arms, and Parliamentarian

**Section 3:** In order to participate in any election of Unit Officers, a Member shall have paid dues for the current fiscal year within which the election is held, at the time of nomination of candidates for office and, in any event, at least two weeks prior to the election.

**Section 4:** All Officers shall be elected annually at the May Unit meeting and shall assume their duties immediately following the meeting."

Pam Klenner has volunteered to Chair our nominating committee and has agreed to let us know who the rest of her team will be at the February meeting. At the writing of this newsletter we know that we are in definite need of a PRESIDENT & 1st VICE PRESIDENT, the committee does need to verify the position's for the rest of the officers. # WISCONSIN AMERICAN LEGION AUXILIARY STATE BOWLING ASSOCIATION TOURNAMENT RULES – READ CAREFULLY

- 1. All senior members of the Wisconsin American Legion Auxiliary, holding 2021 membership card are eligible to enter the tournament under the below rules.
- New bowlers enter the tournament with an average of 145.
- Entrants allowed bowling only once per event.
- Everyone MUST bowl when scheduled.
- 5. For the 2021 Tournament Only: Due to COVID-19 and not knowing the situation in April 2021, entry forms need to be received by March 15, 2021 but entry fees (\$19.00 per bowler, per event) will be requested at a later date.
- 6. No entries shall be accepted after the entry closing date. NO EXCEPTIONS. Hostess city entrants will be given dates and times requested, if possible; otherwise the tournament manager will assign dates and times. NO hostess city entries will be refunded.
- tournament manager will assign dates and times. No nostess city entries will be refunded.

  All events are optional and may be entered for a \$3.00 fee. Paid all events are not transferable unless the substitute replaces original entrant in all three events.
- 8. If a team has only 3 bowlers, only 3 scores can be used. NO blind score will be used.
- 9. This tournament will be conducted on a handicap basis of 75% of the difference between each entrant's average and 200 pins.
- 10. If a substitution is made in the doubles event the substitute must take the place of the bowler she is replacing. NO rearranging of partners will be permitted in the doubles.
- 11. A sub shall be allowed, if one is available, in case of disability after a game has started, in team and doubles only. Only the actual score of the frames bowled shall count if a sub is not available.
- 12. Bowlers entered in all three events will be so scheduled to permit them to complete competition within two days, unless they are doubled with someone who is bowling on another four-woman team at some other time, which prevents scheduling of these participants on same convenient dates.
- 13. Teams will bowl all three games on their scheduled pair of lanes. Doubles and Singles events with be bowled on another pair of lanes.
- 14. Every bowler entered in the individual events must have at least one ball for her personal use. No sharing balls with other bowlers. (House balls are acceptable.)
- 15. If a bowler is absent by the scheduled time and does not arrive by the end of the 4<sup>th</sup> frame of the 1<sup>st</sup> game, absent bowler shall forfeit the first game, but is eligible to bowl 2<sup>nd</sup> and 3<sup>rd</sup> game if arrival prior to the start of the 2<sup>nd</sup> game. This is for Singles and Doubles ONLY.
- 16. Team Champion will receive a plaque for the winning Unit.
- 17. Cash prizes will be determined upon completion of tournament, based on funds received.
- 18. NO SMOKING OR DRINKING WILL BE ALLOWED IN THE BOWLERS SEATING AREA.
- 19. Make sure you are watching for your turn to bowl and keep the games going. There are other shifts for Auxiliary bowling and possible league bowling scheduled after our tournament.

#### CAPTAINS

- 1. Captains must check in and verify lineups 45 minutes prior to starting time. Registration will CLOSE 30 minutes before squad time. This is all necessary due to last minute changes. Thank you in advance for your cooperation.
- 2. When <u>substitutes</u> not registered on entry <u>blank are used</u>, captains shall report same to Tournament Manager before entering contest and present 2021 American Legion Auxiliary membership card of substitute.
- 3. There must be a TEAM CAPTAIN FOR EACH TEAM.
